FAQ

Q: What is California TITLE 20?

A: TITLE 20 is a set of energy efficiency regulations established by the California Energy Commission that governs various products and appliances.

Q: What lighting products are effected?

A: Two main categories are impacted. State-Regulated LED Lamps and State-Regulated Small Diameter Directional Lamps.

State-Regulated LED Lamps - SLED (meet the following criteria):

- Have an E12, E17, E26, or GU-24 type base
- Produce between 200-2600 lumens (products with candelabra bases produce 150+ lumens)
- Produce a white light CCT between 2200K-7000K with a Duv of +/- 0.012
- This category also includes retrofit kits with an E12, E17, E26, or GU24 type base

State-Regulated Small Diameter Directional Lamps - SDDL (meet the following criteria):

- Operates at 12, 24, or 120V
- Has an ANSI ANSLG C81.61-2009 (R2014) compliant pin or E26 base
- Diameter < 2.25"
- Lumen output < 850 lumens, wattage equivalency less than 75w incandescent



- Q: What makes a State-Regulated LED Lamp or State-Regulated Small Diameter Directional Lamp acceptable to be sold in California?
- A: Lamps must meet the applicable design and performance standards, certified to the California Energy Commission (are listed in the state's MAEDBS database) and marked in accordance with TITLE 20.

Q: What is the difference between Tier I and Tier II performance?

A: The CEC introduced requirements for LED lamps in two tiers (phases). Tier I's effective date is 1/1/2018 and Tier II is 7/1/19. Performance under Tier II is significantly higher (efficacy and/or CRI is typically much higher). SDDL are subject to one set of requirements that went into effect 1/1/18.
